A motion was made by Bob Roseberg and seconded by Frank Turnock to approve payment of \$5409.75 to EOR. Approved unanimously.

#### OBWELL CONTRACT

Nothing has changed on the Obwell contract--\$1200 for the year. A motion was made by Frank Turnock and seconded by Roger Vogt to approve signing the contract and designate Steve Hughes to sign the contract. Approved unanimously.

#### CAROL BUSCH/COST-SHARE CONTRACT/CISCO TULLIBEE LAKE PROTECTION/ROUND LAKE, HAZELTON TOWNSHIP

A motion was made by Frank Turnock and seconded by Roger Vogt to approve a cost-share contract for Carol Busch, cost sharing not to exceed 4505.25 or 75% of

the total eligible costs whichever is less. Approved unanimously. This is the last of the Cisco Tullibee Lakes Protection Grant.

#### DICK & KATHY BEATTY/BIG SANDY LAKE 319 COST-SHARE CONTRACT

A motion was made by Bob Roseberg and seconded by Roger Vogt to approve a cost-share contract for Dick & Kathy Beatty, cost-sharing not to exceed \$680 or 50% of the total eligible costs whichever is less. Approved unanimously.

#### TIMBER BAY CAMP/COST-SHARE PAYMENT/MILLE LACS CWP

A motion was made by Frank Turnock and seconded by Bob Roseberg to approve payment of \$1059.60 to Timber Bay Camp. Approved unanimously.

#### CITY OF MCGREGOR/COST-SHARE PAYMENT, DISTRICT CAPACITY 18, FLOOD RELIEF FEASIBILITY STUDY

An invoice March/April was submitted for payment. A motion was made by Roger Vogt and seconded by Frank Turnock to approve payment of \$9250.13 and request the City of McGregor to notify the SWCD when a presentation of the study is being made. Approved unanimously.

#### KARI PAULSEN, WILKINS LAKE/FY 17 COST-SHARE PAYMENT

The islands look pretty good, the geese messed up some of them. Midwest Floating Island paid for the islands that needed repaired and the University of MN planted them. There has been some discussion about landowners on Fleming Lake adopting an island.
